## **Background Investigation:**

Membership in the post is also subject to the successful completion of a background investigation conducted by the department. The investigation will include, but is not limited to, driver's record check, criminal history, employment history, and reference checks. You may also be required to complete a polygraph exam or physical exam, including a drug screen.

- 2. Birth Certificate
